Paper Applications—Paper applications are to be submitted to your local Corps or Service Unit, accompanied by full payment. An application must be filled out for each family member attending camp. Incomplete applications will not be accepted; all required supporting documents (immunization records, supplemental forms, etc.) must be provided.

Online registration—parents/legal guardians can register family members for Family Camp at [www.midlandyouth.com/registration](http://www.midlandyouth.com/registration). The “Register a Camper” option will take you to the online form, where you can set up a user account by entering your email address and creating a password. Please register each member of your family group under the same user account. Supplemental forms and documents are available for download on the registration site as well.

Similar to paper registrations, online registrations will not be accepted as complete until **all mandatory fields are filled out, all required supporting documents are successfully uploaded, and full payment is received by the Corps or Service Unit.**
